## ***Supervised Visitation***

### **Supervised and Monitored Visitation:**

Children deserve to have two parents who share time with them in a safe and structured environment. Supervised and Monitored Visitation allows this to happen. While on Supervised Visits, parents see their children at a neutral location with a neutral person present who is in earshot or eyeshot at all times. While on Monitored Visits, the supervisor drops in on the visiting parent during their visit with the minor child(ren) and speaks privately with the minor children to make sure they are doing well during the visit. Each service lasts as long as it takes for parents to work on their issues, such as parenting issues, anger management, substance or alcohol abuse or other issues. Additionally, Ms. Trotter offers reconciliation therapy for parents and children who have been estranged.

### **How Much Does it Cost?**

Supervised Visitation costs \$45 per hour  
Monitored Visitation costs \$65 per drop in visit  
Supervised Exchanges costs \$20 per exchange  
Additionally, all associates who assist Ms. Trotter in providing supervised visitation have completed a comprehensive competency based training program and participate in continuing education in the field of supervised visitation.

### **Where Do Visits Take Place?**

Visits may take place either on or off-site. Generally, the first few visits take place at the office of Trey Trotter, MS, LMFT. After that, unless otherwise stated in a court order, visits may take place anywhere in the community, at the Supervisor's discretion.

### **How Do I Schedule a Visit?**

Intake interviews of each party must be completed before supervised, monitored visits and exchanges will start. This gives the parties an opportunity to discuss rules and fees. Intake interviews are 1.5 hrs in length and cost \$67.50 each, billed to the party being supervised, unless otherwise stated in a Court Order.

### **About Trey Trotter, MS, LMFT:**

Trey Trotter holds a Masters of Science and is a Licensed Marital and Family Therapist by the State of Oklahoma. She has been in private practice since 2001.

Before that time, Ms. Trotter was the Family Resource Coordinator for the Families in Transition Program at the Tulsa County Courthouse. As the Family Resource Coordinator, Ms. Trotter assisted the Court in changing the way people going through Domestic Court is handled.

Through serving on the Families in Transition Working Committee, she assisted in establishing the court procedure of requiring parents to attend mediation before going to trial as well as establishing the Parenting Plan Conference as the first setting parents attend when they go to court. Working close with judges and attorneys she helped write the original Parenting Coordinator Order the courts still use today to appoint parenting coordinators.

While working at the Tulsa County courthouse, Ms. Trotter also served on the Quality Assurance Panel as well as the Children and the Law Committee. She is currently on the approved court lists of Custody Evaluators and Mediators.

Established in 2001, Trey Trotter, MS and Associates has been providing therapeutic court services throughout Tulsa and surrounding counties. Most recently Ms. Trotter opened a second location in Ponca City.
